Subject: ALLOTMENT OF GUEST ACCOMMODATION TO CANDIDATES SPONSORED/ REFERRED BY UNIVERSITIES /INSTITUTIONS TO NATINAL INSTITUTE OF SOLAR ENERGY(NISE) FOR RESEARCH, INERNSHIP, PROJECT WORK (PERIOD NOT LESS THAN FOUR MONTHS BUT NOT EXCEEDING ONE YEAR) – TERMS AND CONDITION THERE ON

ELIGIBILITY:

Students / candidates doing M.Sc. B.Tech, M. Tech. Ph.D in or through recognized University / Institution and sponsored / referred by respective University/ Institutions to NISE for doing internship - project work / research work for a duration not less than **4 months** and not more than **1 year** shall be considered as students and Guest House accommodation, if desired, would be allotted to him / her subject to availability, on fulfilment of other requirements. The maximum 30 students would be accommodated in different disciplines of internship from all Divisions of the Institute.

TIME PERIOD:

The time period for allotment of accommodation to above students would be 4 months to 1 years. **No allotment of Guest House accommodation would be made beyond 1 year under any circumstances.**

TARIFF:

The students would be allotted Guest House accommodation on subsidized rate of **Rs. 50/- per day per student + service Tax, as applicable**, in advance.

ELECTRICITY CHARGES: The candidates allotted Guest Accommodation shall be liable to pay the Actual Electricity Charges, as fixed from time to time, in accordance with prevailing rates at the time of allotment of guest accommodation on monthly basis by **7th of every month** for previous month, on the basis of actual consumption / reading as per Sub-Electricity Meter installed in each Room.

AVAILABILITY OF CANTEEN FACILITY ON ACTUAL PAYMENT BASIS:

The candidates can avail the **facilities** for the break-fast, lunch and dinner etc. for which they will have to pay directly to the Canteen, as per the fixed subsidized rates.

SECURITY PAYABLE BY THE CANDIDATES FOR AVAILING GUEST HOUSE ACCOMMODATION.

The Candidate availing Guest House accommodation facility shall have to deposit the interest free refundable Security amount of Rs. 3,000/-. The Security Deposit would be refunded at the time of vacation of the room after due clearance of all dues and obtaining "No demand certificate" from care taker of the Guest House and the Canteen Manager.

TARIFF FOR OTHERS

The charges for Guest House accommodation, if allotted to any official other than candidate during the course of tours/ visits for a short duration only, would be @ Rs. 600/- per day + Service Tax, or the rates fixed from time to time, as applicable.

It would be the responsibility of Candidate/ Official to keep the inventory in the room intact and he / she shall be responsible for any loss / damage in this regard.
