1. INTRODUCTION:

National Institute of Solar Energy, an autonomous institution of Ministry of New and Renewable (MNRE), is the apex National R&D institution in the field Solar Energy. The Government of India has converted 25 year old Solar Energy Centre (SEC) under MNRE to an autonomous institution in 23rd September, 2013 to assist the Ministry in implementing the National Solar Mission and to coordinate research, technology and other related works. The institute is involved in demonstration, standardization, interactive research, training and testing solar technologies and systems. It is an effective interface between the Government and institutions, industry & user organizations for development, promotion and widespread utilization of solar energy in the country.

2. Invitation for Quotation:

On behalf of Director General, National Institute of Solar Energy, Gurugram sealed quotations are invited from the technically and financially capable manufacturers/suppliers who are interested to work with NISE for “**Supply, Fabrication / Installation and commission of a rooftop cover of a solar thermal cold storage and a store room for Battery, inverter & thermal storage with Mild steel Sheet in NISE campus**” for safety and environmental protection from rainy days (Approx. Area 1000 Sq. Feet) at National Institute of Solar Energy, GwalPahari, Gurugram, Haryana, India.

3. INSTRUCTIONS TO MANUFACTURER/SUPPLIERS

Eligibility of Bidders

- (i) The Bidder/Vendor should be reputed Supplier / fabricator / installer of M.S.Sheet storage system having an annual turnover of not less than Rs 10 Lakh in each financial year during the last two years. Bidders should enclose copy of audited sheets for financial years. Bidder must have sales tax/GST and income tax registration. Copy of PAN Card and GST/ Sales Tax registration should accompany the quotation. Bidder must have required facilities to manufacture the required items for which the bid is submitted.
The proof of turnover and list of clients shall be submitted with the quotation.
- (ii) The Bidder/Vendor shall be equipped and able to carry out the Client's maintenance, repairs and Spare parts, stocking obligations prescribed by the conditions of the contract
 - (a) That the adequate and specialized expertise is already available or will be made available following the execution of the contract in the Purchaser's city, to ensure that the support services are responsive and adequate.
 - (b) That the Bidder will assume total responsibility for the fault-free operation of equipment / items and Maintenance during the warranty period and

provide necessary maintenance services for three years after end of warranty period if required.

(iii) Bidder/Vendor who does not meet the criteria given above, if they have made untrue or false representation in the forms, statements and attachments submitted in proof of the qualification requirements or have a record of poor performance, not properly completing the contract, inordinate delays in completion or financial failure, etc. are subject to disqualification.

Note: Only Submission of the bid does not suffice for deeming the Order to the bidder; all bidders will undergo a strict scrutiny process to evaluate the bids received by the committee.

4. Technical Specifications :

4.	Complete supply, installation , commission of a rooftop and a store room with all necessary hardware & accessories, with good finishing without sharp corners, burrs etc.

5. General Conditions of Contract

a) **Inspections and Tests:** All routine test & acceptance tests as per relevant standards and specification shall be carried out by the vendor on the premises of the MANUFACTURER. Charges for all these tests for all the equipment / items & components shall be included. Drawings and production data shall be furnished to the inspectors at no charge basis to the Purchaser, Should any inspected or tested Goods fail to conform to the specifications, the Purchaser may reject the goods.

- b) Commissioning Check Tests/ Performance and Guarantee Test:** In addition to the checks and test recommended by the manufacturer, the contractor shall supervise the acceptance tests to be carried out on each set.
- c) Certificate:** The vendor shall furnish, at its own cost, test certificate for the various material and equipment / items as called for. Such certificate shall be from the manufacturers for the particular consignment / lot / piece and shall be duly authenticated by respective consultants.
- d) Packing:** The Supplier shall provide such packing of the Goods as is required to prevent the damage or deterioration during transit to their final destination as indicated in the Contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods' final destination and the absence of heavy handling facilities at all points in transit.
- e) Delivery and Documents:** Delivery of the goods and completion of works should be made within **(3 weeks) three Weeks** from the date of placement of purchase order at **National Institute of Solar Energy, Gurugram – Faridabad Road, GwalPahari, Gurugram – 122 003, Haryana, India.**, Within 24 hours of shipment, the supplier shall notify the purchaser and the insurance company by cable/telex/fax/e mail/phone the full details of the shipment including contract number, railway receipt number/ AWB etc. and date, description of goods, quantity, name of the consignee, invoice etc. The Supplier shall mail the following documents to the purchaser with copy to the insurance company:
- i)** Copies of the Supplier invoice showing contract number, goods' description, quantity, and unit price, total amount;
 - ii)** Acknowledgment of receipt of goods from the consignee(s) by the transporters;
 - iii)** Insurance certificate, if any.
 - iv)** Manufacturer's/Supplier's warranty certificate;
 - v)** Inspection Certificate issued by the Competent Authority, and the Supplier's factory inspection report; and Certificate of Origin.
 - vi)** Two copies of the packing list identifying the contents of each package.
- The above documents should be received by the Purchaser before arrival of the Goods (except where the Goods have been delivered directly to the Consignee with all documents) and, if not received, the Supplier will be responsible for any consequent expenses.
- f) Insurance:** For delivery of goods at the purchaser's premises, the insurance shall be obtained by the Supplier to an amount equal to 110% of the value of the goods from "warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.
- g) Transportation :** Where the Supplier is required under the Contract to transport the Goods to a specified place of destination including insurance, as shall be

Specified in the Contract, shall be arranged by the Supplier, and the related cost shall be included in the Contract Price.

- h) Warranty:** The vendors must provide full comprehensive warranty for a period of 12 months (one year) post installation. During this period they should provide all spare parts required for repair and maintenance. Along with repair maintenance service within 12 hrs. of communication of such services, warranty of one year against manufacturing defects shall be provided. Warranty should be provided by the original manufacturer.
- i) Performance Guarantee:** Performance Guarantee in the form of Bank Guarantee shall be provided against the warranty period of up to one (01) year for 10% of contract value.
- j) Payment:** 100% against delivery, Installation, testing & commissioning and acceptance of the system /equipment / items to the entire satisfaction of the Purchaser.
- k) Taxes and Duties:** Suppliers shall be entirely responsible for all taxes, duties, license fees, road permits, etc., incurred until delivery of the contracted Goods to the Purchaser. Being the purchases for scientific purpose, the customs/Excise duty exemptions are applicable.
- l) Penalty Clause:** If the Supplier fails to deliver the Goods or to perform the Services within the period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as penalty (Half percent of contract price per week of delay subject to a ceiling of 5% of final contract price).
- m) Applicable Law:** The Contract shall be interpreted in accordance with the laws of the Union of India and all disputes shall be subject to place of jurisdiction in Gurugram, Haryana.
- n) Free maintenance and defects liability period of one year.** The vendor service center shall be in Delhi NCR with at least one year of local after-sales Service history in Delhi NCR. Following are the works shall be carried out during the free maintenance period.
- Emergency call back service
 - Inspect, clean, where necessary
 - Adjustment of machinery
 - Replacement of any defective parts
- o) Rejection Terms:** Incomplete, conditional, fax, late quotation will be rejected summarily. Director General, National Institute of Solar Energy reserves the right to

reject any or all the quotations at his discretion without assigning any reason thereafter.

p) Interested Bidder/Vendor are requested to inspect the work site at the address above mentioned and get them acquainted with the nature of work and local conditions that may have a bearing on the rates.
